

Investment Objective & Strategy

The **Wealthstrat Worldwide Flexible Prescient Fund of Funds** will aim to deliver a high level of capital growth. The manager shall have maximum flexibility in terms of asset allocation and shall not be precluded from continually varying the underlying exposure to both local and offshore assets. The fund will employ asset and geographical allocations to reflect changing economic and market conditions to maximise returns over the long term, the **Wealthstrat Worldwide Flexible Prescient Fund of Funds** will, apart from assets in liquid form, consist solely of participatory interest in Collective Investment Schemes which will invest in a diversified mix of assets, including but not limited to equities, property, preference shares, money market and fixed interest instruments. The underlying collective investment schemes are permitted to invest in listed and unlisted financial instruments in line with conditions as determined by legislation from time to time. The underlying portfolios will predominantly invest in offshore jurisdictions subject to the investment conditions determined by legislation however investments in South African Markets may be included from time to time.

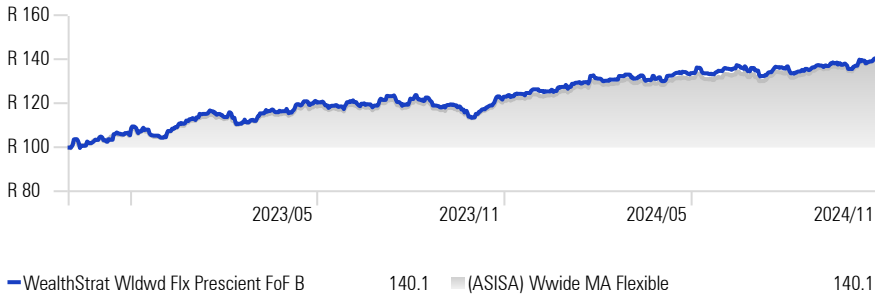

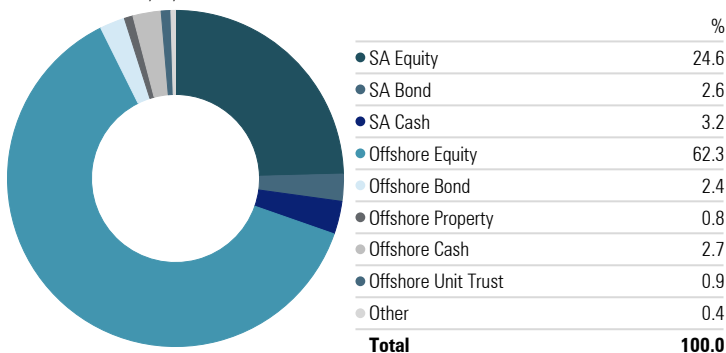

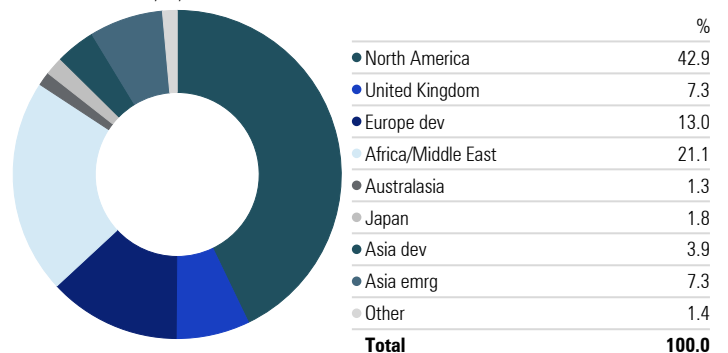

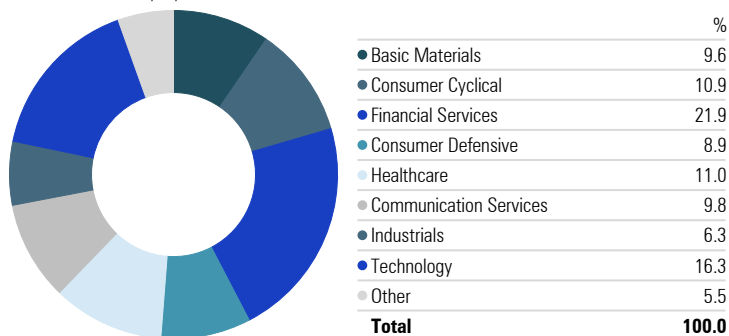
Equity Regional Exposure

Quarterly Fund Commentary

Aggressive investors generated decent returns in the third quarter of 2024, as local and global risk assets recorded strong returns. However, the firm rand acted as a headwind to the performance of global asset classes over the quarter.

The WealthStrat Worldwide Flexible Prescient Fund of Funds returned +1.5% for the quarter and has generated a return of +15.8% over the past year.

The portfolio retains a strong bias toward global and local equities, which we expect to deliver significant inflation-beating returns in the long term.

Asset Allocation

Global equities make up the largest allocation in the portfolio. Global equities produced strong returns this quarter with the strength in non-US stocks being a major development this quarter. The broad MSCI EAFE (developed markets excluding the US and Canada) Index gained 7.3%, ahead of the S&P 500's 5.9% return. Emerging Markets performed even better, advancing 8.7% in US dollar terms. China, the largest component of the Index, soared by 23.5% during the quarter, with most of this gain occurring in the quarter's final days following the announcement of stimulus measures by the Chinese government. Local equities moved higher, driven largely by the Financial (+13.7%) and Industrial (+11.6%) sectors. Large banking and insurance counters produced double-digit returns on the back of general strength in the sector. Momentum (+28.7%), Discovery (+27.6%), OUTsurance Group (+25.0%) and Capitec (+18.0%) were among the best-performing counters in the sector over the quarter. S.A. Industrials (+11.6%) ended the quarter in positive territory, largely driven higher by "S.A. Inc" shares and in particular S.A. Retailers, which rebounded strongly. Mr. Price (+34.4%), Foschini (+24.3%), Spar Group (+14.5%) and Shoprite (+5.7%) ended the quarter posting robust returns. In addition, index heavyweights Naspers (+17.6%) and Prosus (+16.2%) delivered strong returns on the back of the performance recorded by Tencent after the recent stimulus announcement in China. SA Resources (-1.5%) ended the quarter lower, dragged lower by Energy and Platinum shares including African Rainbow Minerals Ltd(-16.6%) and Sasol (-16.0%). Local bonds make up the next largest allocation within the Portfolio. This includes allocations to corporate, government and inflation-linked bonds. Short-dated nominal bonds held up well over the quarter and produced a stable performance, however, they lagged the performance of longer-duration peers. Longer-dated instruments ended the quarter higher as yields moved lower (and prices higher). Nominal bond yields benefited from moderating inflation, the South African Reserve Bank (SARB) beginning its rate-cutting cycle and improving investor sentiment following the elections. Local cash allocations continued to deliver positive returns this quarter. Offshore bond and cash allocations contributed to performance on the back of the actions taken by the US Federal Reserve. The third quarter saw the first Fed rate cut in more than four years and global fixed income markets have reacted positively so far. However, the firmer rand acted as a headwind to the performance of offshore allocations. A small allocation to local listed property contributed to performance this quarter, benefiting from the recent positive sentiment, bringing its quarterly return to +18.7% and is the best-performing local asset class on a year-to-date basis. The fund's asset allocation is broadly similar to the previous quarter.

Fund Selection

The contribution from fund selection was mixed for the quarter.

PSG Equity delivered fourth quartile performance this quarter, despite delivering strong absolute returns. While the fund performed roughly in line with its composite benchmark of 80% FTSE/JSE Capped SWIX and 20% MSCI World Index, for the quarter, it lagged relative to its ASISA SA General Equity peer group. The fund's positions in domestic financials and industrials were contributors to performance over the quarter, with the main contributors being holdings in Discovery (+27.6%), Wilson Bayley Holmes-Ovcon (+44.5%) and Standard Bank (+18.5%). However, the fund's resources and foreign equity positions were detractors from performance this quarter. The main detractors were the fund's holdings of Northam Platinum (-13.8%), Noble Corp (-22.6%) and Shell Plc (-10.1%).

BCI Fundsmith Equity FF delivered fourth quartile performance this quarter, with returns that were behind the MSCI World benchmark and the ASISA Global Equity General peer group. The main detractors over the quarter came from the fund's healthcare positioning, as a large holding in Novo Nordisk (-24.0%) detracted over the quarter. Other detractors in the fund included information technology positions in Microsoft (-9.0%) and Alphabet (-14.0%), which overshadowed contributing positions, such as Philip Morris International (+14.3%), Waters Corp (+17.1%) and Meta Platforms (+7.3%).

Fairtree Equity Prescient produced a top quartile performance and ended the quarter with a double-digit return. The fund outperformed the ASISA South African General Equity category over the quarter. Key contributors include the fund's exposure to SA financials namely, Absa (+12.3%) and Capitec (+27.3%). On the other hand, the fund's exposure to rand hedges detracted from performance this quarter. These include Anheuser-Busch InBev (-6.9%), Richemont (-1.4%) and British American Tobacco (-0.2%).

There were no changes made to the underlying funds in the portfolio in the third quarter.

Summary

We are pleased that the portfolio managed to generate a positive return over the third quarter in a particularly strong local environment. We remain comfortable with the positioning of the Portfolio, both from an asset allocation and a manager selection perspective. The portfolio continues to have a large allocation to global and local equities, which we expect to deliver significant inflation-beating returns over the long term. The fund has adhered to its policy objective.

Glossary

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

Fund Specific Risks

Default risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
