



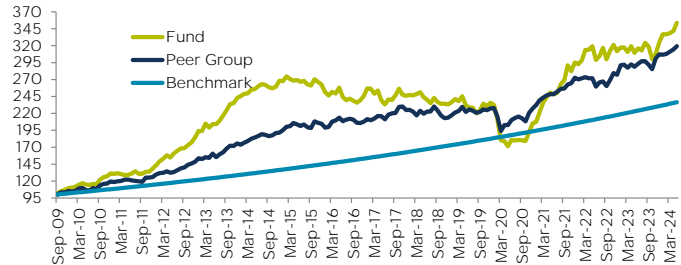
FUND OBJECTIVE & STRATEGY

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

WHO SHOULD INVEST

MONTHLY COMMENTARY

We entered the month with a sense of optimism that elections would bring some political change with a greater focus on economic growth and the fund was up over 3.5% as markets were buoyed by this possibility. The significant showing for the MK party has, however, introduced a high level of uncertainty, which markets hate. Markets would like a coalition or national agreement with a more business-friendly DA but we are potentially a couple of weeks away from any clarity on coalitions.

Reunert, the fund's second largest holding, delivered very solid first half earnings with revenue up 7% and earnings per share up 8%. The renewable power business continues to deliver strong growth with increased sales of circuit breakers into the USA but slower lithium ion battery sales domestically as the battery business shifts from small home applications to larger commercial battery packs. In addition, Reunert remains well positioned in Southern Africa to benefit from renewable projects and the increased demand for copper power cables, particularly for wind farms. The renewable power market is estimated to grow by R90bn until 2026 - an approximately 30% compound annual growth rate. Reunert will focus on the 250kW to 30MW mining and commercial power markets which require a higher level of sophistication. The standout performer was the defense cluster where the order book is at record levels across radars, fuses and radios. The company expects this division to remain strong for many years as Europe and Asia look to rearm and the Middle East countries try to build their own defense sectors, with Reunert being a tier two supplier of components to a large defense system. We anticipate a faster growth in earnings in the second half of the year to September, lifting earnings by c.20%.

Nampak announced the successful disposal of the problematic Nigerian beverage can factory and is well on its way to cleaning up the company to focus on the more profitable business units. Interesting news in the UK press which would benefit Hammerson, another of the fund's holdings, is speculation that the LVMH family's private equity firm, L Catterton, is in discussions to buy luxury goods focused Value Retail for £1.4bn.

The fund is invested in companies with significant growth opportunities but would benefit even more if South Africa's political parties announce a positive election outcome that can keep structural reforms on track and reinvigorate confidence in the political and economic outlook.

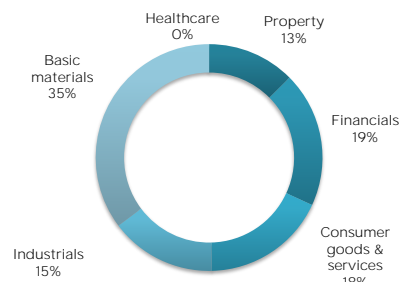
