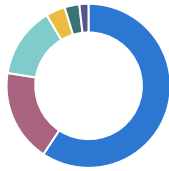

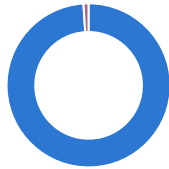
GEOGRAPHIC ALLOCATION (%)

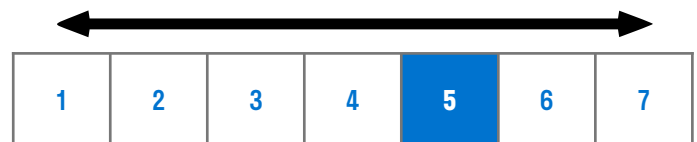
