INVESTMENT AND RETURN OBJECTIVE

The Fund aims to deliver returns close to the MSCI Emerging Markets Index Total Return at low cost. Although the Fund is structured similarly to the MSCI Emerging Markets Index, it is not a tracker fund and can out / underperform the MSCI Emerging Markets Index by small amounts over time.

INVESTMENT PROCESS

The Fund follows an investment process which firstly endeavours to follow the composition of the MSCI Emerging Markets Index closely and secondly seeks enhancement opportunities to secure for investors an optimum overall return. The Fund can use derivatives to create exposure to the MSCI Emerging Markets Index or subsets thereof in a low cost and efficient manner.

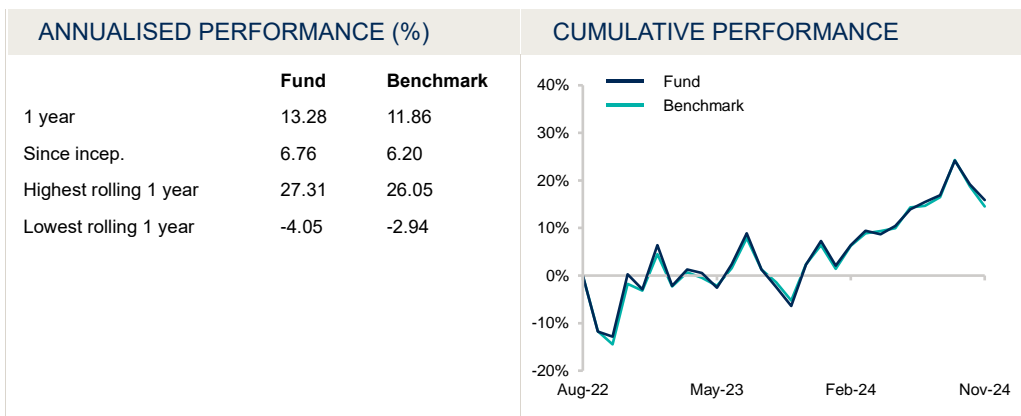
WHO SHOULD INVEST

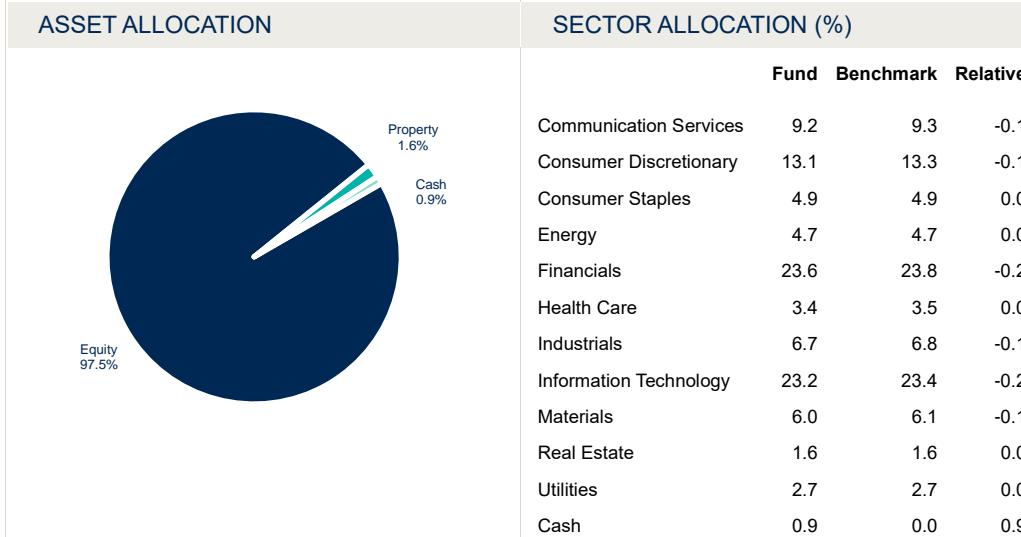
RISK INDICATOR DEFINITION

FUND COMMENTARY

Market Context

Equity markets delivered a mixed bag of returns largely attributed to a resounding victory for the Conservative Republican Party in the US elections. US stocks rallied as Donald Trump was voted into office and market participants positioned themselves for what has been promised to be an expansionary fiscal policy administration. This led Developed Markets higher as the MSCI World index closed the month up 4.59% while the S&P 500 index posted a solid 5.87% return for the month. The rest of the world was seemingly less enthusiastic about the prospect of an increasingly US-centric policy environment and the palpable threat of trade wars in what is still a dollar led global economy. Across the pond, The Euro Stoxx 600 index gave back 2.79% for the month as the earnings outlook for the region deteriorated. Further east, Japan and China similarly closed the month lower in hard currency in the wake of a rampant US dollar. The Nikkei 225 and CSI 300 indices gave back 0.55% and 1.13% respectively. The broader Emerging Markets were not spared as the MSCI EM index closed 3.59% lower.

Fund Positioning

The Fund maintains the maximum effective exposure to the large and mid-cap sectors of the market. The top three sector allocations for this equity exposure were Financials, Information Technology and Consumer Discretionary, with the largest share exposures to Taiwan Semiconductor, Tencent and Samsung.

Outlook

Our outlook has transitioned from moderately negative to neutral, reflecting enhanced valuations. This improvement has been driven by more favorable price-to-earnings, price-to-sales ratios, and relative earnings yields. While financial conditions and overall sentiment remain neutral, economic headwinds persist.

Fund Performance

The Fund was down 2.80% in November, outperforming the benchmark, which fell 3.59%. YTD, the Fund is ahead the benchmark by 0.35%, with a return of 8.0%.

Contributors and Detractors

The positions that contributed most to the absolute performance of the Fund for the month were Naver (+21.5%), Infosys (+5.7%) and HDFC Bank (+3.5%). The largest detractors from the month's absolute performance were Taiwan Semiconductor (-3.3%), Alibaba (-11.5%) and Samsung (-8.4%).

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Dividend Yield: The weighted average dividend yield of all the underlying equity in the Fund. The dividend yield of each company is the dividends per share divided by the price.

PE Ratio: The weighted average price earnings ratio of all the underlying equity in the Fund. The price earnings ratio of each company is the price divided by the earnings per share.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.
