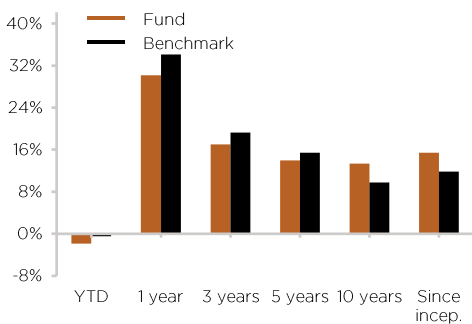

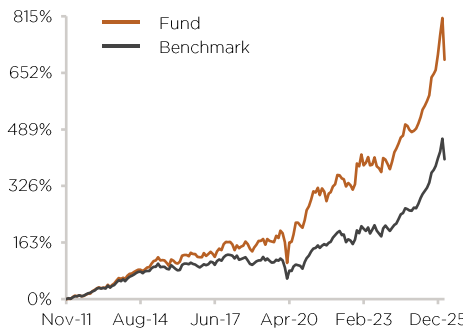
**RISK INDICATOR**

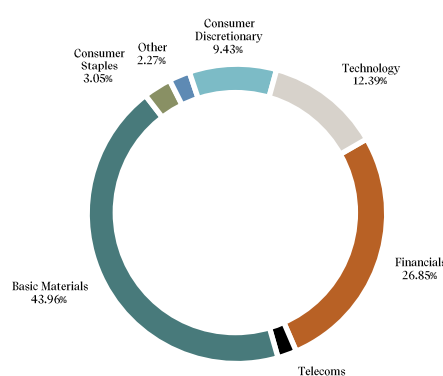

MARKET COMMENTARY

The FTSE/JSE All Share Index (ALSI) decreased by 10.5% in March 2026, while the FTSE/JSE Capped All Share Index (CAPI) decreased by 10.6%. The rand weakened by 6.3% during the month. Resources, Industrials and Financials decreased by 15.9%, 5.2% and 9.7%, respectively. During March, bonds decreased by 6.8%, and cash returned 0.6%. The MSCI Emerging Markets Index decreased by 13.1% (USD), underperforming the MSCI World Index, which decreased by 6.4% (USD). The MSCI South Africa Index decreased by 18.6% (USD). Over March, iron ore increased by 3.4% to US\$102.9/t, and thermal coal increased by 11.6% to US\$110.4/t. Brent crude oil increased by 43.8%, closing the month at US\$104.0/bbl. Gold was down by 11.6% to US\$4668.1/oz, and platinum decreased by 17.5% to US\$1953.7/oz. Palladium decreased by 17.2% to US\$1480.4/oz.

March 2026 was dominated by a single, seismic event: on 28 February 2026, the United States and Israel launched coordinated airstrikes on Iran in what was codenamed "Operation Epic Fury", killing Supreme Leader Ali Khamenei and targeting military and nuclear infrastructure. Iran retaliated swiftly and broadly; the conflict sent shockwaves through every corner of global financial markets and defined the narrative for the entirety of March. The most immediate market consequence was an extraordinary spike in energy prices. Iran's effective blockade of the Strait of Hormuz, through which approximately 20% of global oil and LNG supplies transit, sent Brent crude surging to above US\$120/bbl briefly, its most extreme upward move in a single month since the 1973 oil shock. Global equity markets sold off sharply in response, as risk appetite collapsed. Central banks universally adopted a hawkish tone: the US Federal Reserve held rates while signalling fewer cuts in 2026, noting the conflict's inflationary risks.

Gold's performance in March was nuanced - having reached a record high in January, the precious metal corrected sharply during the month. This was somewhat counterintuitive given the severity of geopolitical tensions, but reflected profit-taking after an extraordinary rally, as well as a stronger US dollar in the initial flight-to-safety response and some easing of immediate ceasefire concerns mid-month after Israeli Prime Minister Netanyahu signalled the conflict could be resolved "a lot faster than people think". By month-end, gold had partially recovered, maintaining its status as a safe-haven asset in an era of profound geopolitical uncertainty and dollar diversification by central banks.

In South Africa, the SARB held its repo rate unchanged at 6.75% at its 26 March Monetary Policy Committee meeting. Heading into the meeting, February headline CPI inflation had come in at the 3.0% target, raising hopes for a further rate cut. However, the SARB now projects headline inflation rising to approximately 4% in the second quarter of 2026, with fuel inflation exceeding 18%. Towards the month-end, tentative ceasefire diplomacy provided some relief to oil markets and risk sentiment. Equities rallied modestly in the final sessions, partly paring monthly losses. Nevertheless, the overriding characterisation of March 2026 remained one of acute geopolitical shock, a reversal of the year's earlier strong performance, and a fundamental reset of the global inflation and interest rate outlook.

The VIX Index (volatility or "fear" index) increased by 27.1% during the month.

The Fund's performance was positively impacted by positions in Glencore (11.78%), Sasol (55.10%) and Shoprite (5.46%), while Impala (-31.25%), AngloGold (-16.84%), Northam (-19.95%) and Gold Fields (-15.74%) detracted from performance. The Fund invests in several focused strategies. The Fund maintains overweight positions in defensive (gold mining, global industrials) strategies, and we prefer higher-quality names over lower-quality ones.



**Glossary**

**Annualised Performance:** Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest Performance:** The highest and lowest performance for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

**Current Yield:** Annual income (interest or dividends) divided by the current price of the security.

**Alpha:** Denotes the outperformance of the fund over the benchmark.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

**Sortino Ratio:** A measure of the risk-adjusted return of a portfolio. It is a modification of the Sharpe ratio but only penalises the returns falling below a user specified target, or required rate of return, while the Sharpe ratio penalises both upside and downside volatility equally.

**Standard Deviation:** The deviation of the return stream relative to its own average.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Max Gain:** Largest increase in any single month.

**% Positive Month:** The percentage of months since inception where the Fund has delivered positive return.

**High Water Mark:** The highest level of performance achieved over a specified period.

**Performance Fee Cap:** The maximum performance fee that can be charged over a specified period

**Total Expense Ratio (TER%):** The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

**Performance fee incl. in TER (%) PF (%):** The Performance Fee is a payment made to the Fund Manager for generating outperformance and is generally calculated as percentage of outperformance, often both realized and unrealized.

**Transaction Costs (TC%):** The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

**Total Investment Charges TIC (%) = TER (%) + TC (%):** The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

**Risk Indicator Definition**

The Portfolio is more diversified than the benchmark, thus holding smaller positions in the largest capitalisation stocks than the benchmark. This comes with the risk of more volatile relative returns to the broader market when the largest stocks in the benchmark outperform. We believe however that this strategy of holding a more diversified portfolio results in lower single stock risk, and whilst there may be periods of underperformance when the large cap stocks rally, we firmly believe in efficient risk management on an absolute basis. The strategy is also exposed to various factors driving investment performance, for example Value and Momentum, and these factors may also experience periods of relative underperformance. Global research has shown however, that consistent long term exposure to these factors lead to investment reward. This portfolio is permitted to invest in foreign securities which may have additional risks (FX Movements for example). However, the portfolio does not currently hold any foreign securities and the manager does not intend on exposing the portfolio to any foreign securities going forward.
