

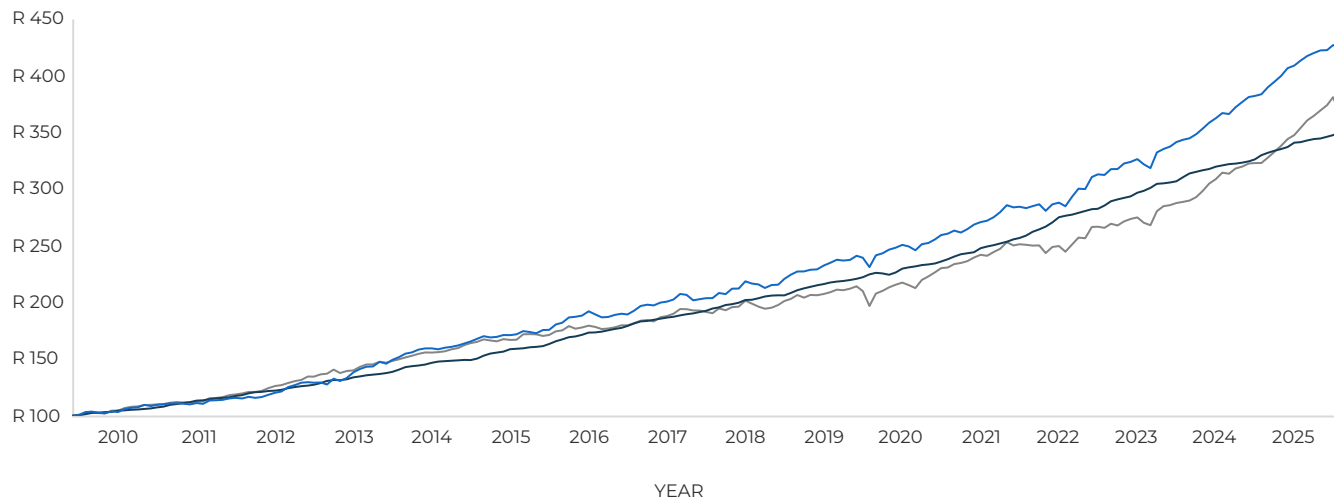
Abax Absolute Prescient Fund is a domestic fund focusing on low volatile returns, balanced across local and global asset classes with maximum 40% equity and 45% foreign exposure. The Fund is Regulation 28 compliant.

The objective is to outperform local inflation +3% p.a., over rolling 3 year periods (net of fees), without any negative 12-month periods. It has a low risk profile, and is suitable for investors seeking some capital growth and income without having to assume high levels of capital volatility. Time horizon: 3 years plus.

The Fund is actively managed and draws upon Abax's full skillset: asset allocation, valuation-based equity and fixed income security selection as well as our hedging and hybrid capabilities.

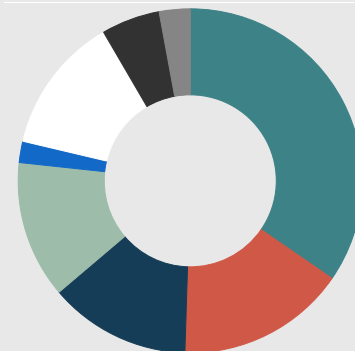

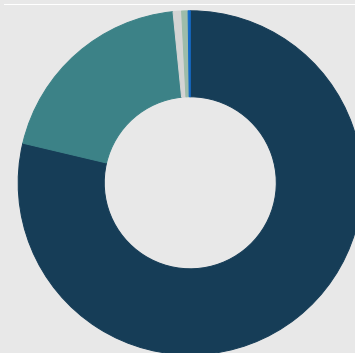

DEFINITIONS & RISKS

Annualised Performance: Longer term performance rescaled to a 1-year period and is the average return per a year, per period. Actual figures available on request.
