INVESTMENT OBJECTIVE

The objective of the CAEP Cautious CPI+3% Prescient Fund is to beat the selected ASISA categories and South African Inflation + 3% on a three-year rolling period.

WHO SHOULD BE INVESTING?

The CAEP Cautious CPI+3% Prescient Fund will provide a solution to investors who have a medium-term investment horizon and who require capital stability and real income growth.

FUND UNIVERSE

The Fund will invest in a combination of equity, listed property, and fixed income funds. The Fund can have a maximum effective equity exposure (including international equity) of up to 60% and a maximum effective property exposure (including international property) of up to 25% of the market value of the portfolio. The portfolio is permitted to invest in listed and unlisted financial instruments in line with the conditions as determined by legislation from time to time.

INVESTMENT STRATEGY

The CAEP Cautious CPI+3% Prescient Fund is a low-risk multi-asset class, medium equity solution targeting CPI+3% over a rolling 3-year period, providing asset class diversification.

GLOSSARY

NAV: The net asset value represents the assets of a Fund less its liabilities.

Alpha: Denoted the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Max Gain: Largest increase in any single month

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Average Duration: The weighted average duration of all the underlying interest bearing instruments in the Fund.
