Investment Objectives

The actively managed ETF aims to generate long-term capital appreciation while mitigating downside risk through strategic asset allocation in globally listed ETFs, which serve as proxies for various asset classes.


Investment Process

The investment process is driven by our use of advanced algorithms that monitor and optimise our allocation to asset classes. We specfically minimise draw-down volatility when needed and allow to increase portfolio volatility when the market conditions are favourable. The dynamic asset allocation approach enables us to adapt to prevailing market conditions.

Fund Profile

In order to achieve this objective, the portfolio invests in a flexible combination of investments in international equity, bond, money, or property markets. The fund has flexibility in its asset allocation between asset classes, countries and regions. The fund is managed with assets being allocated between various markets and asset classes to reflect changing economic and market conditions to maximise total returns over the long term. There may be inclusion of Assets in liquid form and non-equity securities which are considered consistent with the portfolio's primary objective, and that legislation may allow from time to time.



Moderate - High Risk



Information and Disclosures

Collective Investment Schemes in Securities (CIS) should be considered as medium to long-term investments. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's. During the phase in period TER's do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.
