



FUND OBJECTIVE & STRATEGY

The ClucasGray Future Titans Prescient Fund has a flexible mandate to invest in a range of asset classes but will typically have high exposure to companies outside of the Top 40 Index. The fund is permitted to invest 25% offshore plus an additional 5% in Africa. The primary objective of the fund is to achieve real long-term capital growth ahead of CPI + 6%. The fund looks to acquire fast growing, mispriced, mid-and small-cap shares, "Future Titans", on the back of high conviction fundamental investment calls. The fund has a deep value / activist bias.

WHO SHOULD INVEST

MONTHLY COMMENTARY

The fund delivered 3.74% in January with the flexible index delivering 2.12%. The graph shows the monthly moves. You will note that the fact sheet only shows performance of the fund for one year and beyond. This was not a ClucasGray decision but rather the administrator and regulator instructing that these details be removed which we find rather strange in a legislated environment of full disclosure.

January got off to a strong start as precious metals roared higher until a huge sell off on the last day of the month caused by the announcement of a more hawkish Fed Governor coupled with higher margin requirements at the commodity exchange, shaking out over-leveraged speculators. The thesis on gold remains relevant as global central banks diversify away from treasuries - China for example now has 8.5% of reserves in gold versus the US Fed at 75% so there is room for a lot more buying. In addition, global investors seek hard assets to shelter from the threat of higher inflation as budget deficits drift higher, driven by short-term populist politics. Tourism had a great year in 2025 as foreign arrivals into South Africa hit a new record, rising above 10.5m. This is hugely beneficial for Southern Sun Hotel which has been reporting strong occupancy and rising room rates. HCI in their recent AGM indicated that they will be selling their property portfolio, having sold 5 of 13 properties so far. They also indicated that they would be seeking a buyer for the Southern Sun Hotels, where HCI are the largest shareholder, and we believe any sale will be in excess of R16bn to a foreign buyer.

Advtech launched their new university brand, Emeris, into which they will consolidate their three university brands. Consider that 345,000 matriculants achieved university exemptions in 2025, with government universities only able to accept 235 000 students. This is a huge growth opportunity - Advtech grew their 2025 tertiary business by 14% to over 60,000 students and we expect further growth in 2026. Tertiary education is a low capex, high margin business with high barriers to entry which is why Advtech has been a fantastic performer for the fund.

The outlook for South Africa has improved significantly with a stronger Rand, lower inflation, lower fuel prices and rising consumer sentiment. Coupled with attractive starting valuation levels, this should bode well for SA Inc shares.


