/ Portfolio description

The primary objective of the portfolio is to achieve long term capital appreciation by investing in a concentrated portfolio of global equities. The portfolio manager acquires global equities at levels below the assessment of the companies' fair values. The portfolio manager also takes cognisance of global economic, sector and investment trends to tilt the portfolio towards attractive regions, sectors, and companies. The Integrity Global Equity Fund is required to invest a minimum of 80% of the portfolio in equities and is therefore suitable for investors with an investment horizon of five years or longer.

Integrity diligently follows a **value investment philosophy and process**. This is the same investment philosophy and process applied in managing the Integrity Global Equity Strategy, with track record since 11 September 2012.

The portfolio has adhered to its policy objective since its inception.





/ Relative performance

During the quarter, equity markets continued to rally despite the evolving geopolitical landscape that proves to be unpredictable. Against this backdrop, the Fund achieved a return of 5.92% ahead of the benchmark return of 3.29%. Overall, the Fund had a strong year with a total return of 39.01% compared to the 22.34% of the MSCI All Country World Index. Considering the holdings, the Fund benefitted materially from share selection with the top contributors to performance being Samsung, Abercrombie & Fitch, Barrick Mining and Intel. The Fund also benefitted from a rally in its pharmaceutical holdings (Bristol-Myers Squibb, GSK and Merck). Unfortunately, the Fund's overweighting to B&M European Value Retail, Paramount Skydance, Fresenius Medical Care and its cash allocation to the Japanese yen hurt its performance over the quarter. The Fund was negatively impacted by not having any exposure to Alphabet (Google) which contributed significantly to the benchmark's overall performance in the fourth quarter. The MSCI ACWI Value Index had a total return of 3.66% over the quarter compared to the return of the MSCI ACWI Growth Index of 2.84%. Given the remaining overvaluation of growth counters, the relatively elevated global bond yield environment and the uncertainty regarding global economic activity, the Investment Manager believes that this backdrop should be supportive of value over growth for the patient investor.

/ Fund composition

The Investment Manager made several portfolio changes during the quarter given the strong performance of many underlying holdings. The Investment Manager was active in rotating from certain counters that traded near or above their estimated fair values to more attractive investment opportunities. Additionally, exposure to certain counters was reduced from a risk mitigation perspective as they became too large a constituent given the inherent risks and return potential. As a result, exposure to GSK, Samsung, AngloGold Ashanti, Barrick Mining, Mercedes Benz, Anglo American, Intel, Glencore, Baidu, and Merck was reduced. The Fund exited exposure to LVMH which performed well past its recent inclusion in the Fund. Exposure was initiated to Nedbank, Abercrombie & Fitch, Charter Communications, Mondi, Baxter International, TFG and Adobe which the Investment Manager believes offer upside potential at current levels. Additionally, the Investment Manager increased exposure to Sanofi, B&M European Value Retail, Albertsons, and Bristol-Myers Squibb. The Fund has significant cash reserves which will be deployed once attractive investment opportunities present themselves.

/ Glossary

Annualised performance: Annualised performance shows longer-term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The Net Asset Value represents the assets of a Fund less its liabilities.

/ Risks

Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets.
