





RISKS & DEFINITIONS

Annualised Performance: Longer term performance rescaled to a 1-year period and is the average return per year, per period. Actual figures available on request.

Currency Exchange Risk: Changes in the relative values of individual currencies may adversely affect the value of investments and any related income.
