RISK INDICATOR AND WHO SHOULD INVEST

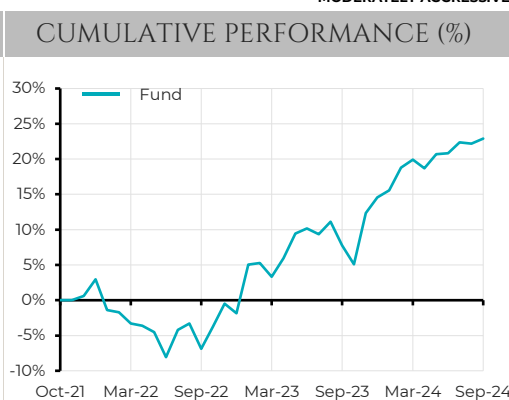

RISK INDICATOR



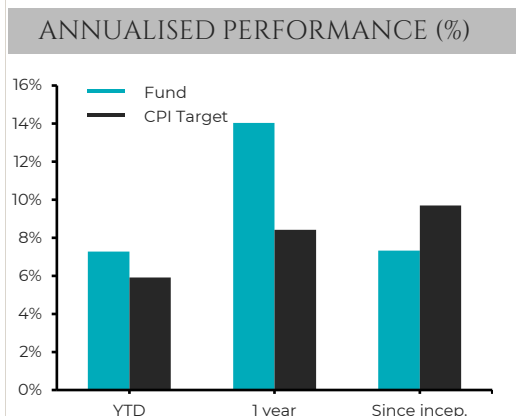

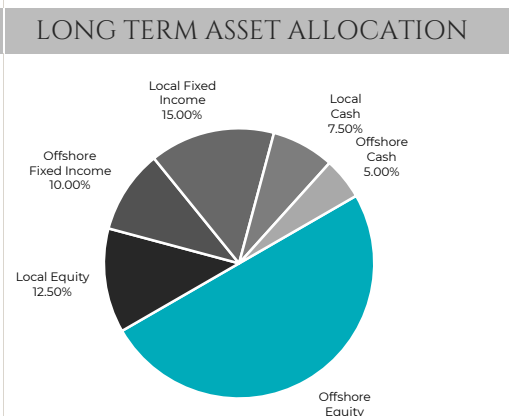

FUND COMMENTARY

Year to date equity performance has been pleasing. The MSCI World Index has returned 18.9% with the MSCI Emerging Market Index returning 16.9%. Global government bonds have unfortunately not performed well year to date, returning 0.8% (All returns are stated in USD). Locally, the Capped Swix has provided a return of 15.9% year to date, the ALBI has returned 16.7% with SA Property surprising on the upside and returning 30.3% year to date.

Looking at specifically September performance, Emerging Markets outperformed their Developed Market counterparts. The MSCI World Index was up 1.83% with the Emerging Market Index up 6.68%. Local Equities returned 3.97% in September, Listed Property was up over 5%, with Local Bonds also up 3.86%. The Rand strengthened by over 3% versus the USD during the month of September.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
