# **Glossary Summary**

Annualized Performance shows longer term performance rescaled to a 1 year period. Annualized performance is the average return per year over the period. Highest & Lowest Returns for any 1 year over the period since inception have been shown. Active Share is the percentage of a portfolio that differs from its benchmark. Active Share can range from 0% for an index fund to 100% for a portfolio with no overlap with an index.
