

Interactive Equity Prescient Fund A

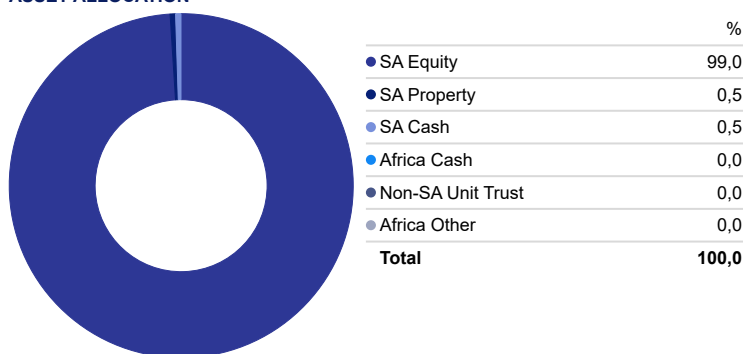
INVESTMENT OBJECTIVE

The fund is an actively managed South African general equity portfolio with a focus on maximizing total returns. The portfolio's objective is to offer medium to long-term capital growth. The portfolio will invest a minimum of 80% of its net asset value in South African equity securities, including listed shares on the Johannesburg Stock Exchange (JSE) and other approved South African exchanges. Up to 20% of the NAV may be allocated to money market instruments, cash, or other short-term investments during periods of elevated market volatility or when attractive investment opportunities are limited. The portfolio may invest across all sectors of the economy but will maintain diversification within sectors to mitigate concentration risk.

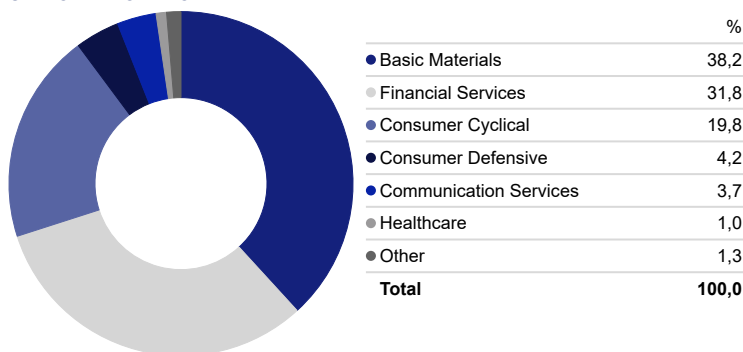
INVESTMENT POLICY

The portfolio has a long-term focus and invests in securities across all sectors of the JSE Securities Exchange which trade below their intrinsic value or have capital appreciation potential.

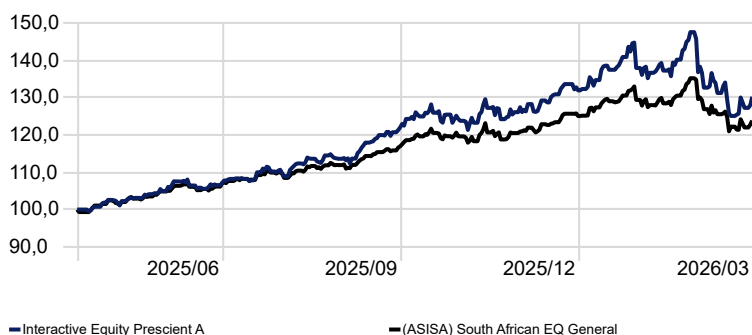

FUND COMMENTARY

The Interactive Equity Prescient Fund delivered a **-1.01% return over the past three months**, compared to the ASISA South African Equity General category, which returned **-0.88%** over the same period. Over six months, the fund returned **7.33%**, slightly behind the category return of **7.76%**.

Performance during the quarter was characterised by **heightened volatility and meaningful dispersion across sectors**, with stock-specific outcomes driving returns.

Positive contributions were primarily driven by the resources sector, particularly gold and diversified mining counters. AngloGold Ashanti (**+16.25%**) and Glencore (**+39.10%**) were standout performers, benefiting from strong commodity price dynamics, while BHP Group (**+12.86%**) provided additional support. Select domestic exposures, including Discovery (**+9.59%**) and MTN (**+15.31%**), also contributed positively.

Detractors were concentrated in large-cap rand hedge and consumer-facing counters. Naspers (**-21.96%**) and Prosus (**-26.24%**) weighed on performance amid weakness in global technology shares, while consumer stocks such as Richemont (**-19.47%**) and Foschini (**-15.94%**) came under pressure due to constrained consumer conditions.

Within resources, performance was mixed, with certain platinum counters and gold stocks lagging, highlighting **divergence within the commodity complex** during the period.

From a positioning perspective, the fund remains focused on **high-quality South African businesses with strong cash flow generation and resilient balance sheets**, while maintaining **select exposure to resource counters** where valuation support and commodity dynamics remain favourable.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Alpha: Denotes the outperformance of the fund over the benchmark.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

FUND SPECIFIC RISK

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.
