#### **INVESTMENT OBJECTIVE**

The investment objective of the Feeder Fund is to achieve capital appreciation over the long term. The Feeder Fund aims to achieve this investment objective through obtaining exposure to the Underlying Fund (Omba Global Equity Fund, sub-fund of the Omba Investments ICAV), a DIVERSIFIED portfolio consisting primarily of GLOBAL equities and equity-related securities.

The Underlying Fund is permitted to invest in listed and unlisted financial instruments in line with the Undertaking for Collective Investment in Transferable Securities (UCITS) regulations and Underlying Fund supplemental documents determined by legislation or amendment thereof from time to time.






#### MARKET COMMENTARY

Equity markets (MSCI ACWI, -2.3% MoM) finished December lower but logged an exceptional 2024. Despite the seemingly great performance, concerns about the breadth of the market remain. US equities (S&P 500, +25.0% YoY) were the performance drivers this year given their weight in MSCI ACWI and their outperformance vs. European (Stoxx 600, +9.5% YoY - around 3% in USD) and Emerging Market (MSCI EM\$, +8.1% YoY) peers. Aside from country concentration in global markets, within the US we also observe performance concentration to a handful of mega cap stocks. The median stock has severely underperformed the market capitalisation weighted index, as evident in S&P 500 Equal Weight (+13% YoY). In December, yields repriced to higher levels across the US (US10Y,  $+37.9 \mathrm{bps}$  MoM), Europe (DE10Y,  $+27.6 \mathrm{bps}$ ) and the UK (GB10Y,  $+32.7 \mathrm{bps}$ ), due to concerns on inflation and subsequently fewer cuts expected by the Fed in 2025. This affected equity and bond markets alike (iShares Global Corp Bond UCITS ETF, -1.7% MoM) and especially equity segments with higher borrowing costs such as US small caps (Russell 2000, -7.8% MoM). Even though the S&P 500 Equal Weight index falls under "large-cap", it also suffered from shifting yield expectations (-6.3% MoM). Over in Europe (Stoxx 600, -0.4% MoM) and the UK (FTSE 100, -1.3% MoM), equities finished the month lower, especially when one considers USD strength (DXY Index, +2.6% MoM) against the Euro (EURUSD, -

2.0% MoM) and Pound Sterling (GBPUSD, -1.4% MoM). Japan finished higher (Nikkei 225, +4.5% MoM) as the Yen weakened (USDJPY, +5.1% MoM). Korea (KOSPI, -3.4% MoM, -9.6% QoQ) and India (Nifty 50, -2.0% MoM, -8.2% QoQ) fell for the third consecutive month, while Chinese offshore equities ended higher (Hang Seng, +3.3% MoM). In December, we increased our exposure to semiconductors, taking advantage of the sector's short-term underperformance against the broad market since the Summer of 2024.
