INVESTMENT OBJECTIVE

To provide long-term capital growth to investors and target returns of CPI+4% over rolling 7-year periods. This fund is well diversified across asset classes, actively managed with a higher exposure to global markets and is not Regulation 28 compliant.

RISK INDICATOR AND WHO SHOULD INVEST

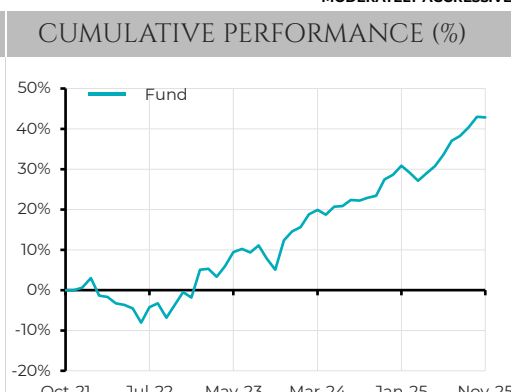

RISK INDICATOR



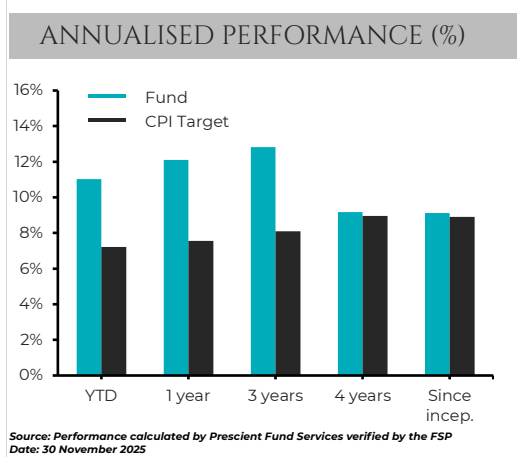

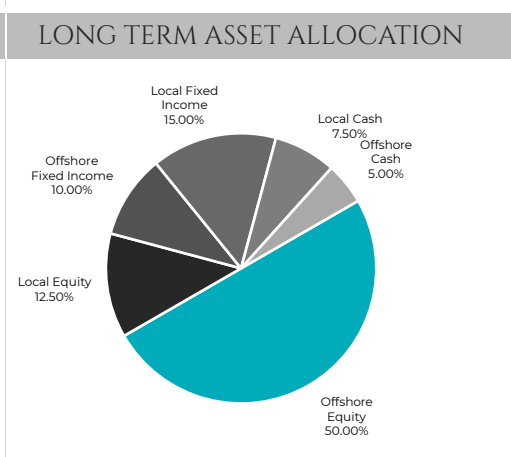

FUND COMMENTARY

Looking at SA asset classes over the most recent 1 year, the Capped Swix was up 36% and the All Bond Index returned 20.5%. Offshore asset classes, the MSCI All Country World Index was up 18.2% (SA asset classes are in rands, while Offshore asset classes are in US Dollars). The Rand over the last 1 year vs the USD has strengthened by approximately 5%. Global markets experienced a month of consolidation and volatility, characterised by a rotation away from high-flying technology stocks. A 43-day US government shutdown finally ended on the 12th of November, releasing delayed data that showed a softening labour market. This fueled late-month expectations for a Federal Reserve rate cut in December. South Africa was one of the world's best-performing markets in November, driven by domestic reforms and a rally in precious metals. The Rand strengthened by 1.3% against the US dollar, trading below R17.00 to the Dollar for the first time in over two years.

GLOSSARY

Annualised Performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Total Expense Ratio (TER%): The Total Expense Ratio (TER) is the percentage of the net asset value of the class of the Financial Product incurred as expenses relating to the administration of the Financial Product.

Transaction Costs (TC%): The Transaction Costs (TC) is the percentage of the net asset value of the Financial Product incurred as costs relating to the buying and selling of the assets underlying the Financial Product.

Total Investment Charges TIC (%) = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
