

# STONEHAGE FLEMING EQUITY PRESCIENT FUND

#### INVESTMENT OBJECTIVE

The aim is to maximise investor total return over the long term through a focused portfolio of high quality JSE listed equity securities.

The Fund has adhered to its policy objective.

#### FUND FEATURES

A concentrated equity-only portfolio that may invest across all sectors of the JSE. The portfolio will hold between 20 - 30 companies.

### FUND COMMENTARY

February was a busy month on the JSE with a number of holdings releasing financial results or updates.

BidCorp's half-year results showed resilience in a tough environment. Group revenue grew +3.6% (+7.1% constant currency), headline earnings rose +6.0% (+10.0% constant currency), and the dividend increased +6.7%. The company completed eight acquisitions and maintains a strong balance sheet (net debt/EBITDA at 0.6x). Guidance from management is for continued growth as first half momentum continues into the second half.

Santam released a pleasing trading update for the full year to December 2024, reporting continued improvement in underwriting margins. Headline earnings per share (HEPS) is expected to rise by 40%-60%.

AB InBev's FY2024 results showed a +2.7% revenue increase despite volume declines in China and Argentina. Improved pricing, lower commodity costs, and controlled expenses boosted earnings per share by +15.7%. Strong free cash flow and reduced capital expenditures supported a +22.0% dividend increase and \$750 million in share buybacks (~40% of the \$2 billion plan announced in October).

Dis-Chem's five-month update to 31 January 2025 reported +7.2% revenue growth. Retail revenue rose +5.6%, and wholesale revenue increased +11.1%. The group now operates 333 retail stores, 286 Dischem pharmacy stores and 47 Dis-chem baby stores.

Boxer's trading update, their 1st since listing, for the 45 weeks to 5 January 2025 noted a 10%-12% revenue growth, aligning with pre-listing guidance. Trading margins were also guided to be in the target range of 5.0%. Liquor store rollouts have been delayed due to licensing approvals, however their Superstore rollout plans remain on track.


- Seek to identify exceptional businesses with sustainable long-term growth prospects and durable competitive advantages
