INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve significant real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - High Equity funds over a full market cycle by maintaining meaningful exposure to growth assets like equities.

INVESTMENT PROCESS

The Fund invests across a range of assets including equities and interest bearing instruments, both domestically and offshore. The asset allocation is anchored at the long-term strategic allocation, but can be varied tactically to target outperformance of the benchmark by capitalising on signals of significant market mispricing. Where possible, a process of enhanced indexation is utilised within asset classes to deliver stable incremental alpha.

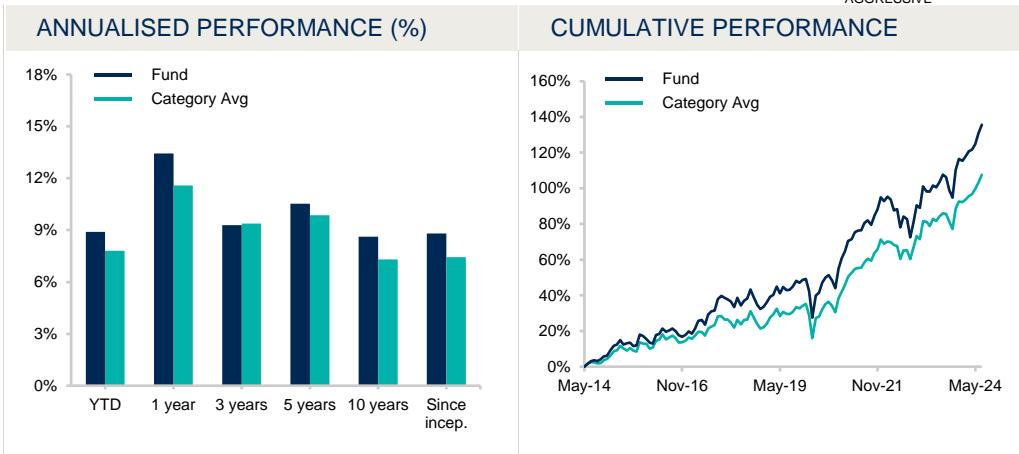
WHO SHOULD INVEST

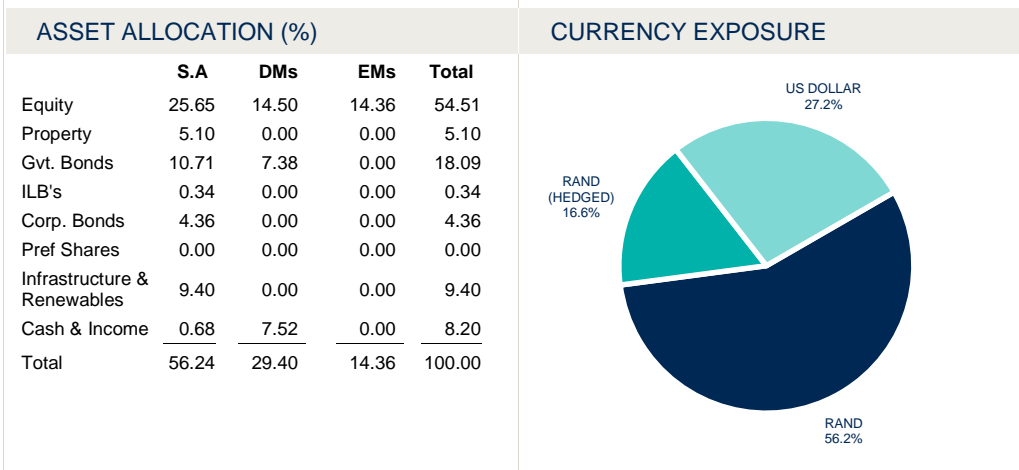
RISK INDICATOR DEFINITION

FUND COMMENTARY

July witnessed notable political developments. An attempted assassination of former President Donald Trump during a campaign rally left him injured but not seriously harmed. A week later, President Joe Biden announced the end of his re-election campaign, abruptly concluding his long political career and reshaping the race for the White House just four months before Election Day. Vice President Kamala Harris has been formally chosen as the Democratic nominee. Currently, Donald Trump leads Kamala Harris in the polls, with a vote share of 47.7% to 46.9%. Although there are no major elections scheduled for August, all attention will turn to the U.S. elections in November.

Regarding Central Banks, the Federal Reserve maintained its key interest rate at 5.25% to 5.5%, noting "some further progress" toward its 2% inflation target. Fed Chair Jerome Powell indicated that a rate cut in September is "on the table," contingent on continued favourable inflation data. The Bank of England implemented its first interest rate cut in over four years, reducing the key rate to 5%. This decision was made by a narrow 5-4 vote, with Governor Andrew Bailey emphasizing a cautious approach moving forward. The People's Bank of China unexpectedly lowered the cost of its one-year policy loans by the most since April 2020, following a recent cut to a key short-term rate, signalling increased support for the slowing economy. The central bank also reduced the medium-term lending facility rate by 20 basis points to 2.3%, the first decrease in nearly a year.

In South Africa, the central bank kept its main interest rate steady at 8.25%, as expected. The Monetary Policy Committee's decision was split, with four members in favour of holding rates steady and two advocating for a 25-basis-point cut. Meanwhile, Japan's central bank raised its benchmark interest rate to "around 0.25%" from the previous range of 0% to 0.1%, marking the highest rate since October 2008, when it was set at 0.3%. The Bank of Japan (BOJ) stated it would continue to raise the policy interest rate and adjust the degree of monetary accommodation, depending on the realization of its economic outlook.

Global equities generally rose in July, driven by benign inflation data and moderately dovish Central Banks, which boosted risk asset prices. However, markets finished the month below their intramonth highs as investors retreated from the artificial intelligence frenzy, and some earnings reports were disappointing. The MSCI World Total Return Index gained 1.8%. In the U.S., the S&P 500 added 1.2%, while the Dow Jones surged 4.5%. Technology stocks lost momentum, leading to a 0.8% decline in the Nasdaq Composite. Major European indices all closed in positive territory. Japan's Nikkei bucked the trend among developed markets, falling 1.2%.

In emerging markets, performance was mixed: China's Shanghai Composite lost 1%, while Hong Kong's Hang Seng Index dropped 2.5%. Conversely, India and South Africa saw continued momentum in their equity markets. India's Nifty 50 Total Return Index rallied 4%, marking its ninth consecutive monthly gain, while South Africa's All Share Index rose 3.9%.

Global bonds rallied, with prices increasing by 2.7% as yields fell. The U.S. Treasury Index gained 2.2%. Locally, the All Bond Index (ALBI) surged nearly 4%, marking its fourth consecutive monthly gain. Commodities mostly ended lower amid concerns that the U.S. economy might be heading into a recession. The Bloomberg Industrial Metals Index dropped by more than 7%, and oil prices fell by 6.6%. However, gold surged over 5%, reaching a new all-time high during the month.

GLOSSARY

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

Fund Specific Risks

Default Risk: The risk that the issuers of fixed income instruments may not be able to meet interest payments nor repay the money they have borrowed. The issuers credit quality is vital. The worse the credit quality, the greater the risk of default and therefore investment loss.

Derivatives risk: The use of derivatives could increase overall risk by magnifying the effect of both gains and losses in a Fund. As such, large changes in value and potentially large financial losses could result.

Developing Market (excluding SA) risk: Some of the countries invested in may have less developed legal, political, economic and/or other systems. These markets carry a higher risk of financial loss than those in countries generally regarded as being more developed.

Foreign Investment risk: Foreign securities investments may be subject to risks pertaining to overseas jurisdictions and markets, including (but not limited to) local liquidity, macroeconomic, political, tax, settlement risks and currency fluctuations.

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction cost is a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER.

This yield is subject to change as market rates and underlying investments change.
