# The Mentenova Global Equity Prescient Fund is an actively managed global equity fund. The fund will be actively managed with exposure to equities to maximize returns for investors. Given the risk profile, an investment horizon of more than 5 years is required.

#### **INVESTMENT OBJECTIVE**

The objective of the Fund is to outperform its benchmark being the category average of the Global-Equity-General ASISA category, on a total return basis. The above fund adhered to the investment policy objectives as stated in the Supplemental Deeds.

#### INVESTMENT UNIVERSE

The Fund will actively invest in global equities. The fund can invest across various jurisdictions and markets subject to the investment conditions determined by legislation from time to time.

#### **STATEMENT OF CHANGES**

R10 000 The portfolio's exposure to the energy and mining sectors have been reduced over the past quarter, built up a significant overweight position in offshore cash, which is readily deployable into defensive and quality counters amid the backdrop of macro volatility.









#### **DRAWDOWN (SINCE INCEPTION)\***







#### **EQUITY SECTOR ALLOCATION**




#### **GEOGRAPHIC ALLOCATION**

#### GLOSSARY

Annualised performance: Annualised performance show longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Standard Deviation: The deviation of the return stream relative to its own average.

Aggressive: Aggressive means you can afford to take a higher level of risk (i.e., have a greater exposure to equities) because of your investement time horizon and/or your appetite for risk. You know that in taking the risk, you need to be patient if you want to achieve the results. So you are willing to invest for the long-term and are prepared to tolerate some volatility in the short term, in anticipation of the higher returns you expect to receive in five years or beyond.
