## MINIMUM DISCLOSURE DOCUMENT

#### INVESTMENT AND RETURN OBJECTIVE

The Fund aims to achieve healthy real returns over the long term and to outperform the ASISA category average of the South African - Multi-Asset - Low Equity funds over a full market cycle by maintaining moderate exposure to growth assets like equities.

## **INVESTMENT PROCESS**

This Fund invests in local and offshore money market, bonds and inflation-linked bonds, property, preference and ordinary shares, derivatives and unlisted instruments to meet the investment objectives. Fund performance can be generated from taking interest rate views or duration, yield enhancement via credit instruments, asset allocation and exposure equities.

## WHO SHOULD INVEST

Investors seeking real returns coupled with a stable and attractive income yield via significant exposure to the South African interest bearing markets. Although the Fund's mandate allows investment up to 40% in equities, it is expected to have lower actual exposure on average. This Fund is suitable to investors with a medium to long-term investment horizon and is Regulation 28 compliant.


#### RISK INDICATOR DEFINITION

These portfolios typically have moderate equity exposure or in the case of bond funds, longer duration bond exposure, resulting in some capital volatility over the shorter term. They are managed in such a manner that the probability of capital losses over one year periods is unlikely. 

## **FUND COMMENTARY**

The U.S. economy expanded at a robust pace in the third quarter, with household spending accelerating ahead of the upcoming election and the federal government boosting defence expenditures. Inflation-adjusted GDP rose at an annualised rate of 2.8%, following a 3% increase in the previous quarter. Consumer spending, which represents the largest component of economic activity, grew by 3.7%, the highest rate since early 2023, driven by broad increases across goods like autos, household furnishings, and recreational items.

In South Africa, in our local Medium Term Budget Policy Statement (MTBPS), tax revenue collection estimates were revised down, while expenditure forecasts saw a sharp upward adjustment. This highlights the new coalition government's challenge of attracting more investment to the region's largest economy. The fiscal deficit is expected to widen to 5% of GDP for the year through March, up from the 4.5% projected in February. Africa's largest economy is now forecast to grow by an average of 1.8% over the next three years - a slight increase from prior estimates, but still insufficient to keep pace with population growth. The debt-to-GDP ratio is anticipated to stabilise by the 2025-26 fiscal year, though now at a higher level of 75.5% compared to February's projection of 75.3%.

Looking forward, with the U.S. elections concluded, the world awaits the US Presidential inauguration and any subsequent policy changes that may arise.

October saw equity returns mixed across regions. The U.S. S&P 500 Index lost nearly 1%, driven by a decline in technology stocks, with the tech-heavy Nasdaq Composite losing 0.52%. Overall, the MSCI World Index slipped 2.04%, while its Emerging Markets counterpart fell by 4.38%. Locally, the All Share Total Return Index posted a slippage of -0.92%, nearly marking an eighth consecutive month of growth. The index's performance up until the end of last month was largely buoyed by resource companies, particularly those with exposure to palladium

The Fund currently favours an underweight towards developed equity, while having a neutral allocation towards SA bonds and equity as well as emerging market equity. In addition the Fund holds a strongly positive view towards rand strength.

The Fund ended the month down, mostly due to the poor performance of local, emerging and developed market equity.

#### **GLOSSARY**

Annualised performance: Annualised performance shows longer term performance rescaled to a 1 year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest performance: The highest and lowest performance for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Current Yield: Annual income (interest or dividends) divided by the current price of the security.

CPU: Cents Per Unit to the Glossary

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk free rate per unit of risk adopted by the fund.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

% Positive Month: The percentage of months since inception where the Fund has delivered positive return.

## **Fund Specific Risks**
