

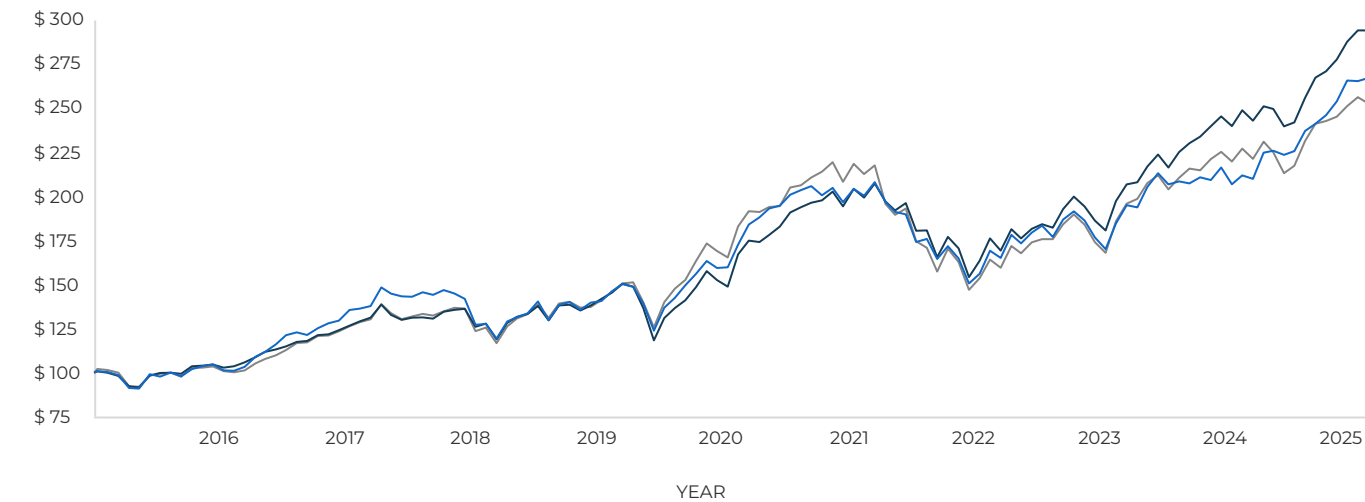
**Abax Global Equity Fund** is a US dollar denominated fund with a mandate to invest in listed global equities.

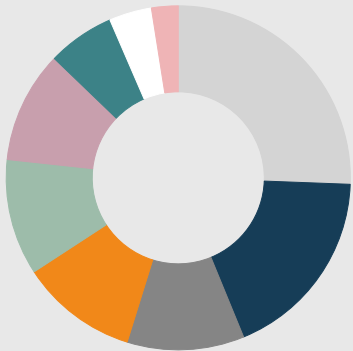

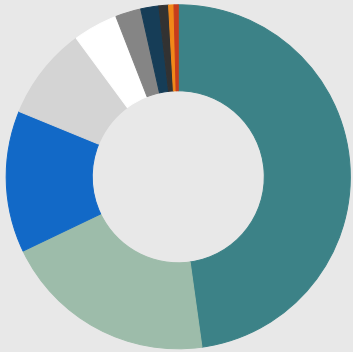

<b>Annualised Performance:</b> Longer term performance rescaled to a 1-year period and is the average return per a pear, per period. Actual figures available on request.
