

MONTHLY COMMENTARY

The CGGF NAV per share rose +0.2% in September while the Morningstar Aggressive Allocation peer group advanced +1.9%. The Fund rose +2.5% for the quarter, lagging the peer group's +4.6% gain as Technology - to which the Fund has a large exposure - had a more difficult quarter.

Global markets were volatile in the third quarter, with mixed readings on key economic indicators shifting expectations for the pace of US interest rate cuts back and forth. US labour markets softened, with payroll additions coming in below estimates in July (+114 000) and August (+142 000) before surprising on the upside in September (+242 000). Despite remaining fairly low, a rising unemployment rate (SEP 4.1%) this year has raised concerns about economic growth. US inflation (SEP 2.4%), on the other hand, has continued to moderate, allowing the Federal Reserve to lower interest rates for the first time this cycle. The Fed cut by a larger-than-expected 0.5% in September, with the market expecting a further 1.5% of reductions over the next 12 months.

From an equity perspective the third quarter went against the prevailing trend, with rotation away from recent leaders. European markets (Stoxx 50 +6.3%) outperformed their US counterpart (S&P500 +5.5%) in USD terms, partly due to a weakening US dollar. Chinese equities (CSI300 +20.2%) staged a sharp rally as the Chinese government rolled out a series of monetary stimulus measures to stabalise the ailing economy. On a sectoral basis, recent leaders such as Information Technology (+0.9%) and Communication Services (+4.0%) rose only marginally following a steep sell-off earlier in the quarter. Instead, money flowed to more cyclical-and value-oriented sectors such as Utilities (+16.1%), Financials (+9.9%) and Industrials (+9.8%) as the stock market rally broadened out.

Financial services companies contributed positively to the Fund's third quarter performance: PayPal rebounded (+34.5%) with the new management team's growth strategy taking shape, while Euronext (+17.2%) and Mastercard (+11.9%) continued to push higher. Nike (+17.3%) also recovered some recent losses after announcing a change in management. In contrast to last quarter's trends, Semiconductors weighed on third quarter returns with ASML (-18.5%) and Samsung (-21.0%) falling the most.

The Fund actively increased Healthcare exposure during the quarter, adding positions in McKesson - the largest pharmaceutical distributor in the US - and Novo Nordisk, which holds a leading position in the fast-growing obesity drug market. Healthcare is our preferred defensive sector, offering strong non-cyclical growth rates supported by long-term demographic trends such as an ageing population. The Fund reduced exposure to cyclicality, exiting Samsung on a fading memory chip cycle and lowering exposure to pure discretionary spending by exiting the positions in eBay and Starbucks.

At the end of September the Fund had an underlying exposure to equities of 93.1%, property 2.5% and 4.4% cash.

The Fund has adhered to its investment policy.

The number of participatory units at 30 June 2024 was 474 169.




FUND ASSET ALLOCATION
