VUNANI GLOBAL EQUITY FUND

A sub-fund of Prescient Global Funds ICAV Fund Commentary for the quarter ending 30 September 2024



Having reached an all-time high in mid-July, the MSCI World Index promptly fell over 8% in US dollars, before staging a somewhat bumpy recovery to close the quarter at yet another all-time high.

Ultimately, the index posted a gain of 6.4%, with global markets being led by a rally in US small caps and emerging markets, which benefited from a Federal Reserve interest rate cut and Chinese central bank stimulus.

The Russell 2000 Index of US small cap companies gained 9.3% during the quarter, while the CSI 300 Index of Chinese A-shares gained 22% in US dollars.

The MSCI Emerging Market Index gained 8.8%, while US equities took a back seat for once, the S&P 500 and Nasdag Composite gaining a more modest 5.9% and 2.8% respectively.

The Chinese Central Bank unveiled the largest stimulus package since the Covid-19 pandemic in response to deflationary pressures in the economy which put the official growth target of 5% at risk. By lowering of bank reserve requirements approximately US\$142 billion will be made available for lending, while a lowering of the rate on existing mortgages by 50bps and a cut in the downpayment requirement for home loans to 15% are designed to stimulate the stagnant real estate market. While Chinese financial markets responded positively to the stimulus package, broader structural reforms are required to address real economic activity, given weak credit demand.

The Vunani Global Equity Fund – Class C delivered a net US dollar return of 6.8% during the quarter ahead of its benchmark, which returned 6.4%. Following a period of poor relative performance, it was pleasing to outperform the benchmark over the quarter, more so, given the strong relative performance of the Fund during the downturn from mid-July.

Sector rotation away from tech heavy, cyclical areas of the market, notably IT and Communication Services into defensive sectors such as Consumer Staples, suited the Fund's positioning, with strong stock selection results boosting relative returns.

Starbucks (+60bps), Unilever (+38bps), Intercontinental Exchanges (+34bps) and Reckitt Benckiser (+32bps) all provided positive attribution relative to the benchmark, along with Nvidia, which we do not own and which declined 1.7% during the quarter.

Negative attribution during the quarter came from the likes of ASML (-75bps), Novo Nordisk (-53bps), Adobe (-29bps) and Disney (-28bps), while Tesla, which rallied 32% during the quarter and to which the Fund has no exposure, detracted 23bps of relative performance.
