## INVESTMENT OBJECTIVE

The aim is to maximise investor total return over the long term through a focused portfolio of high quality JSE listed equity securities.

The Fund has adhered to its policy objective.

#### **FUND FEATURES**

A concentrated equity-only portfolio that may invest across all sectors of the ISE. The portfolio will hold between 20 - 30 companies.

#### **FUND COMMENTARY**

2024 proved to be a volatile period for global equities with markets navigating a cooling inflation environment and digesting the outcomes of elections in over 60 countries. For the calendar year 2024 global markets delivered mostly positive performances, driven largely by the US. Headline US indices the S&P 500 Index rose +25.0% and the Nasdaq Index (containing a higher weighting towards technology stocks) rose +29.6%. The MSCI World Index rose by +19.2% for the year, while the MSCI Emerging Markets Index advanced by +8.1% (all figures are Total returns in USD).

Despite a weak start to the year, the JSE Capped SWIX Index (SWIX) recovered from a -6.0% decline in the first quarter to ultimately deliver a positive return of +13.4% for the calendar year. This rebound was largely driven by the outcome of the national election and the positive sentiment surrounding the formation of the Government of National Unity (GNU). The Stonehage Fleming Equity Prescient Fund had a pleasing year, returning +14.5%.

Calendar year performance across the JSE's major sectors showed significant divergence, with the JSE Financial, Industrial and Resource Indices returning +23.1%, +18.5% and -8.6% respectively. Within the broader South African consumer sector, Fund holdings Capitec (+57.4%%) and Pepkor (+49.9%%) were standout performers. Capitec benefitted from continued client growth and product expansion across its platform, while Pepkor successfully executed its strategy of growth and margin improvement. Prosus (+34.0%) and Naspers (+33.8%) delivered robust returns reflecting improving operating performances from Tencent (and Prosus's other investments) and the positive impact from the ongoing share buybacks at Prosus and Naspers.

Looking ahead to 2025, continued moderation in inflation is expected to support the case for lower interest rates both in the U.S. and domestically. China's underwhelming economic recovery in 2023 and 2024 will remain a key focus, as will geopolitical uncertainties, including South Africa's ongoing GNU consolidation, Trump's trade policies, and ongoing conflicts in Ukraine and the Middle East. Potential risks notwithstanding, with valuations on the JSE still below long-term averages and continued optimism surrounding the domestic economic outlook, the environment should support a constructive foundation for returns in the coming year.


- · Seek to identify exceptional businesses with sustainable long-term growth prospects and durable competitive advantages
