

The objective is to outperform cash, as represented by 110% of the STeFI Call Index, with a high degree of capital stability and is suitable for conservative investors seeking high levels of income.

The Fund is actively managed and draws upon Abax's valuation-based fixed income security selection, asset allocation and hedging capabilities.





DEFINITIONS & RISKS

Annualised Performance: Longer term performance rescaled to a 1-year period and is the average return per year, per period. Actual figures available on request.
