

The Laurium Africa USD Bond Fund aims to outperform the Standard Bank Africa Sovereign Eurobond (excl. South Africa) Total return index at lower levels of volatility over time.

# Investment Strategy

The Fund aims to invest in African (ex-South Africa) fixed income and fixed income-like assets. More specifically this will entail investing primarily in USD and EUR denominated fixed income instruments (eurobonds) issued by African sovereigns. There are over 20 African sovereigns issuing eurobonds via the Euroclear markets in Europe. A eurobond is a USD denominated bond issued outside of the United States. The Fund may also invest opportunistically in local currency sovereign and corporate fixed income securities up to a maximum of 25%.



## Commentary

September in the African bond markets began much the same as August – with the market worrying about global rates and economic indicators early in the month, and then continuing to grind higher after these short-lived concerns, along with the rest of EM and global bonds, but in the absence of much country-specific Africa news.

The fund returned 1.6% for the month, with key contributions coming from Egypt (where we own both USD eurobonds and EGP-t-bills), Kenya and Cote d'Ivoire. Nigeria, Morocco and Gabon were also positive for the month. The detractors, albeit small, were Angola and Senegal, with falling oil prices weighing on them.

Going forward we see ongoing good returns from the Africa eurobond space as spreads over US treasuries continue to tighten, and a yield to maturity of the fund of close to 11%
