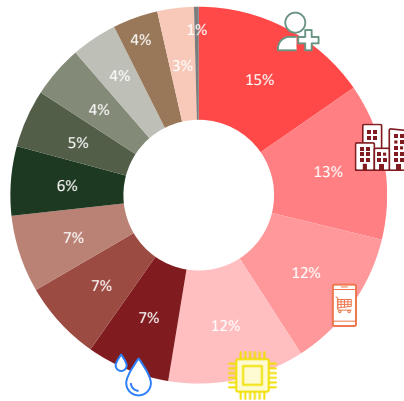
INVESTMENT OBJECTIVE

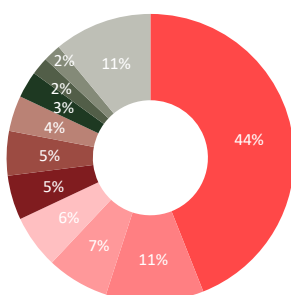

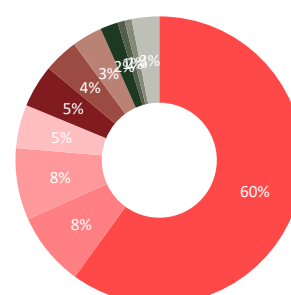

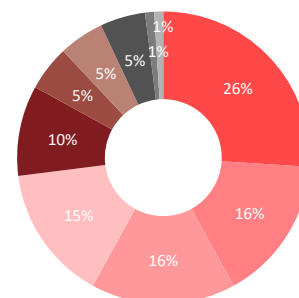
MARKET COMMENTARY

US exceptionalism (S&P 500, +4.3% QoQ, +15.3% YTD) drove markets higher in Q2 (MSCI ACWI, +3.0% QoQ) as the US economy continues to decelerate – unemployed persons reached two-and-a-half year highs (continuing jobless claims end-June 2024, +26k to 1.858m), core personal consumption expenditure growth has slowed (US Core PCE May 2024, +2.6% YoY vs +2.8% YoY previous) and sentiment in services has weakened (ISM Services Index June 2024, 48.8 vs. 52.7 consensus and 53.8 previous). Technology stocks (S&P 500 Info Tech, +9.3% MoM, +13.8% QoQ) rose in June due to the expectation of lower rates in typical “bad news is good news” fashion. Performance concentration, both regional and sectoral, expressed by Info Tech and Nasdaq 100 (+6.3% MoM, +8.0% QoQ) is a major concern as unprecedented earnings growth of top constituents such as Nvidia (Return: +36.7% QoQ, 1Q EPS: +19% QoQ/+462% YoY) fuels outperformance. This meant that semiconductors, led by Nvidia (+12.7% MoM) and ASML (+10.7% MoM), and cybersecurity were the best performing themes in June. European equities fell (Stoxx 600, -1.1% MoM) amid political uncertainty with health care (MSCI Europe Health Care, +1.7% MoM), a long-term overweight in our portfolio, providing a glimmer of hope. Emerging markets (MSCI EMS, +4.0% MoM) performed well, driven by semiconductor-heavy Korea (KOSPI, +6.3% MoM) and India (Nifty 50, +6.8% MoM). China underperformed (Hang Seng, -1.1% MoM) meaning China technology alongside clean energy were the most significant negative contributors for the month. In June, we closed our position on International Distribution Services (-4.1% MoM, +20.5% YTD) to realise gains and avoid potential volatility relating to the ongoing takeover. We therefore increased our exposure to cybersecurity which is a high-conviction theme. Finally, we took advantage of MercadoLibre’s (-4.8% MoM) recent weakness to enter the LATAM eCommerce leader, eyeing a recovery in its main market, Argentina.

GLOSSARY OF TERMS

Active Share	Active share measures the percentage of a fund's holdings that are different from a comparative fund's holdings. In this case the OMBA ICAV fund's holdings are compared with the iShares MSCI ACWI UCITS ETF.
Annualised Volatility	Annualised volatility is a statistical measure of the magnitude of the historical daily (logarithmic) returns of the portfolio NAV, scaled to be representative of a full calendar year using a 258 day count. Only the NAV of trading days are used in calculating this measure.
Annualised Return	Annualised return is a measure which rescales returns, for periods greater than one year, to a 12-month geometric average return.
Best/Worst 12-Months	Respectively, the maximum and minimum % change in NAV Per Share over a 12-month period using daily performance data.
NAV Per Share	Net Asset Value (NAV) Per Share represents the total market value of the portfolio less liabilities and divided by the number of outstanding shares.
Positive / Negative Month(s)	A month is positive (negative) if the NAV Per Share, of a specific share class, increases (decreases) in value from the last day of the previous month to the last day of the following month.
Risk Indicator	The risk indicator for the Fund is set at 4 as this reflects the market risk arising from the proposed investments. The risk indicator is determined using historical data or, where historical data is not available, using simulated historical data. Historical data, such as is used in calculating the synthetic indicator, may not be a reliable indication of the future risk profile of the Fund. Upon sourcing the underlying holdings within each of the ETFs: 77.2% are from 28 Jun 2024, 3.9% are from 02 Jul 2024, and 19.0% are from 31 May 2024. Upon sourcing Equity Breakdown data from Refinitiv, unclassified data (which was not used) for each of the presented measures are: 2.0% for Company Market Cap data, 4.9% for Price-Earnings Ratio data and 33.0% for Dividend Yield data. Price-Earnings Ratio data from Refinitiv greater than 80 were capped at 80 (this amounts to 2.4% of Equity data). Within the Equity Breakdown section, Sector Breakdown is the sector to which each of the underlying companies are exposed (unclassified data: 2.1%), Country Breakdown is the country of headquarters for each underlying company (unclassified data: 2.1%) and Currency Breakdown is the currency in which each underlying company trades and it does not necessarily reflect the currency of exposure (unclassified data: 2.1%).
