INVESTMENT OBJECTIVE

The aim is to maximise investor total return over the long term through a focused portfolio of high quality JSE listed equity securities.

The Fund has adhered to its policy objective.

FUND FEATURES

A concentrated equity-only portfolio that may invest across all sectors of the ISE. The portfolio will hold between 20 - 30 companies.

FUND COMMENTARY

The JSE welcomed Boxer Retail Limited (Boxer) to the board on November 28th 2024. Boxer, founded in 1977 and acquired by Pick n Pay in 2002, has grown from 35 stores with annual sales of R800 million to 489 stores as of 25 August 2024. Targeting lower-to-middleincome urban, peri-urban, and rural markets in South Africa (SA), Boxer is a 'discount' retailer offering a focused range of around 3,000 Stock Keeping Units (SKUs), compared to Shoprite's 11,000 SKUs. It operates across three formats: 300 Boxer Superstores, 159 Boxer Liquors, and 30 Boxer Build stores.

Boxer competes on price, convenience, and store experience, with its customer value proposition centred on discount combinations ("combos") and innovative deals. Its defensive business model benefits from a limited product range, which enhances focus, reduces costs, and increases scalability.

The grocery retail sector contributes approximately ZAR1.2 trillion (16% of GDP) to SA's economy. While discount retailers hold only \sim 6.2% of SA's formal grocery market, compared to \sim 38% in Poland, the model shows strong growth potential. Boxer is expected to gain market share from formal and informal competitors as discount retail penetration is expected to rise.

Management plans to open 25-30 new Superstores and 35-40 Liquor stores annually, targeting 8%-10% annual space growth. For the 2025 financial year, 65 new stores (26 Superstores and 39 Liquor stores) are projected.

We view the investment case to be attractive supported by a stable and impressive management team, healthy cash flow generation, a focussed and scalable business model and a sustainable growth profile supported by store openings and market share growth. The Stonehage Fleming Equity Prescient Fund participated in the IPO at the R54 issue price.


